# SCHOOL NUTRITION DIRECTOR OF THE YEAR AWARD

The School Nutrition Director of the Year Award for school nutrition employees is designed to recognize the valuable program contribution of persons who may work with the school food and nutrition specialists, managers, supervisors, and superintendent to oversee the day-to-day operations of an entire district's food service program.

A Director, Assistant Director, or Supervisor position typically requires culinary, nutrition, and business expertise and their responsibilities include, but are not limited to, complying with federal policies, financial management, and advanced operations management. They play an essential role in the functionality of school food service operations and it would be our honor to recognize them for all their hard work and dedication.

Local Chapter Procedures: The school food and nutrition employees (excluding the director) will nominate one TASN member from the school food and nutrition staff to represent that school in the system competition. Each employee should vote by a secret ballot if more than one member is nominated, i.e. one director, one assistant director, and one supervisor. Each person's program-influencing qualities should be considered in the selection of the person who receives the School Nutrition Director of the Year Award.

- ✧ **This information should be given to the principal or superintendent who prepares the School Nutrition Director of the Year entry form for the school's entry in the system competition.**

**The entry form should be submitted to TASN Headquarters office by February 15, 2025. Entries received after February 15, 2025 will not be considered.**

All school districts are encouraged to participate in the School Nutrition Director of the Year Award. The recipient's names (one per chapter) will be published in the fall issue of TASNews and they will be recognized at the Annual Conference in June.
